Dr. TANAKA Akihiko (President, Japan International Cooperation Agency (JICA))

Served as a professor at the Institute for Advanced Studies on Asia at the University of Tokyo (1998-2012, 2015-2017), vice president of the University of Tokyo (2009-2012), president of JICA (2012-2015, 2022-), and president of the National Graduate Institute for Policy Studies (2017-2022)) .



His Excellency Mr. Estifanos Afeworki Haile (Ambassador Extraordinary and Plenipotentiary, Embassy of the State of Eritrea in Japan)

Began working in the Provisional Government of Eritrea in 1991. Ambassador to Japan since 2003. Dean of the African Diplomatic Corps in Tokyo since 2014.



Mr. YONEYAMA Yasuaki (Special Representative in Japan, World Bank)

Joined the Ministry of Finance in 1995. Assumed current position in 2021 after having served at the African Development Bank and the IMF.



Ms. NAGASAKA Yuko (Representative of Kenya, RESULTS Japan)

Coordinated health policy advocacy in RESULTS Japan. Since 2018, contributed to doubling the TB detection rate with a total of 200 volunteers in the slums of Nairobi, Kenya. Assisted the Ministry of Health to improve the quality of health services in Kenya.




Mr. HONDO Kazuki (Managing Executive Officer, Member of Board, Nippon Export and Investment Insurance (NEXI))

Ms. SUZUKI Takako (Member of the House of Representatives, Japan-African Union (AU) Parliamentary Friendship League)

Elected to the House of Representatives in 2013. Parliamentary Vice-Minister of Defense (2018-2019) . State Minister for Foreign Affairs (2021-2022) . Deputy Secretary-General of the Liberal Democratic Party.
